

**SPECIAL CALLED MEETING MINUTES OF THE BOARD OF MAYOR AND

The Board of Mayor and Selectmen of the City of West Point, Mississippi held a special called meeting the 15th day of May 2018 at 9:00 a.m. in the downstairs conference room at City Hall, 580 Commerce Street, West Point, Mississippi. Members present were Mayor Harmon A. “Robbie” Robinson, presiding, Selectwoman Leta Turner, Selectman Keith McBrayer, Selectman William Binder, Selectman Ken Poole, and Selectman Jasper Pittman.
