

**SPECIAL CALLED MEETING MINUTES OF THE BOARD OF MAYOR AND  
SELECTMEN  
FOR THE CITY OF WEST POINT, MISSISSIPPI  
Wednesday, March 20, 2019 10:00 A.M.**

The Board of Mayor and Selectmen of the City of West Point, Mississippi held a special called meeting the 20th day of March 2019 at 10:00 a.m. in the downstairs conference room at City Hall, 580 Commerce Street, West Point, Mississippi. Members present were Mayor Harmon A. "Robbie" Robinson, presiding, Selectwoman Leta Turner, Selectman Keith McBrayer, and Selectman Jasper Pittman. Selectman William Binder and Selectman Ken Poole were absent. Also present City Clerk Eddie A. Longstreet, CAO Randy Jones. City Attorney Orlando Richmond was absent.

The Mayor called the meeting to order. The invocation was given by City Clerk, Eddie A. Longstreet. The Mayor noted that the purpose of the meeting was to declare an emergency to repair parts of Main Street at Calhoun Street.

Selectwoman Leta Turner made the motion to declare an emergency exists under Section 31-7-13 (k) according to the Annotated Mississippi Code of 1972, and to authorize an emergency repair contract with PERMA Corp., Inc. to repair damages to Main Street Sewer line.
