

**SPECIAL CALLED MEETING MINUTES OF THE BOARD OF MAYOR AND
SELECTMEN

The Board of Mayor and Selectmen of the City of West Point, Mississippi held a special called meeting the 3rd day of July 2018 at 8:30 a.m. in the downstairs conference room at City Hall, 580 Commerce Street, West Point, Mississippi.
