

**SPECIAL CALLED MEETING MINUTES OF THE BOARD OF MAYOR AND

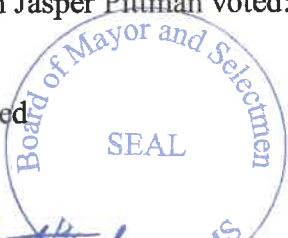
The Mayor then called for motion to adjourn. Selectman Keith McBrayer made the motion. Selectwoman Leta Turner seconded the motion.
