

**SPECIAL CALLED MEETING MINUTES OF THE BOARD OF MAYOR AND  
SELECTMEN  
FOR THE CITY OF WEST POINT, MISSISSIPPI  
Friday, May 21, 2021 8:00 A.M.**

The Board of Mayor and Selectmen of the City of West Point, Mississippi held a special called meeting the 21<sup>st</sup> day of May 2021 at 8:00 a.m. downstairs at City Hall, 580 Commerce Street, West Point, Mississippi. Members present were Mayor Harmon A. "Robbie" Robinson, presiding, Selectwoman Leta Turner, Selectman William Binder, and Selectman Jasper Pittman. Selectman Ken Poole and Selectman Keith McBrayer were absent. Also present City Clerk Eddie A. Longstreet, and CAO Randy Jones. City Attorney Orlando Richmond was absent.

The Mayor called the meeting to order. The invocation was provided by Selectman William Binder. The Mayor noted that the purpose of the meeting was to declare state of emergency for expedited replacement of failing water main line on West Church Hill Road.

Selectman Jasper Pittman made the motion to declare an emergency exists under Section 31-7-13 (k) according to the Annotated Mississippi Code of 1972, and to authorize an emergency repair contract with PERMA Corp., Inc. to repair damages to West Church Hill Road water main line. Selectman William Binder seconded the motion. (See attached exhibits for description of damage and price for repair.)
