

**SPECIAL CALLED MEETING MINUTES OF THE BOARD OF MAYOR AND

The Board of Mayor and Selectmen of the City of West Point, Mississippi held a special called meeting the 22<sup>nd</sup> day of June 2021 at 5:30 p.m. upstairs at City Hall, 580 Commerce Street, West Point, Mississippi. Members present were Mayor Harmon A. "Robbie" Robinson, presiding; Selectwoman Leta Turner, Selectman William Binder, Selectman Ken Poole, Selectman Keith McBrayer and Selectman Jasper Pittman. Also present City Clerk Eddie A. Longstreet, CAO Randy Jones and City Attorney Orlando Richmond.

The Mayor called the meeting to order. The invocation was provided by City Attorney Orlando Richmond followed by the Pledge of Allegiance. The Mayor noted that the purpose of the meeting was to follow the agenda before the Board.

5. Consider/approve annual airport insurance quote from Coburn Insurance Agency
6. Approval to spread over the minutes MCRG bad debt from WPES
7. Approve travel for Cody Parker Firefighter-EMT to attend the MS Fire Academy Fire Inspection Class

Andy Davis reported there were no findings related to the financial statements that were required to be reported by Governmental Auditing Standards. However one Statement of Condition was noted that both the Electric Department and Sewer & Water Department employee time cards are lacking supervisor approval signatures before the payroll is processed.
