The Board of Mayor and Selectmen of the City of West Point, Mississippi held a special called meeting the 20<sup>th</sup> day of June 2024 at 5:30 p.m. upstairs City Hall, 580 Commerce Street, West Point, Mississippi. Members present were Mayor Rodrick “Rod” Bobo presiding. Selectman William Binder, Selectman Keith McBrayer, and Selectwoman Leta Turner were present. Selectman Ken Poole was absent. Motion Carried.


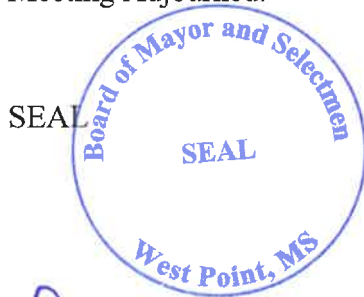
The Mayor called for a motion to adjourn the meeting.
